March 2, 2010 Regular Session convenes

March 2, 2010, NOON Deadline for filing bills for introduction

April 20, 2010 (50th day) Last day for committee meetings

April 26, 2010 All bills are immediately certified

April 30, 2010 (60th day) Last day of Regular Session

To track the progress of a bill, go to **Online Sunshine** at: <http://www.leg.state.fl.us>. Click on the link to the Senate. On the left-hand sidebar, enter the bill number and click on "Go" or hit "Enter" on your keyboard. This will bring up a summary of the bill and the current actions taken on it. If you want to view the full version of the bill, scroll down until you see BILL TEXT. Click on the PDF format and you'll see a copy of the full bill, which you can print or save.
